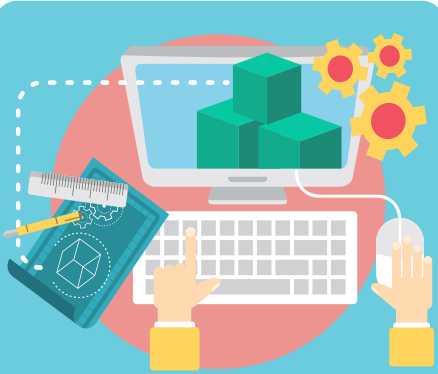

The programme provides a 5-level approach to help companies build up their capabilities progressively. Companies participating in this programme will gain recognition and benefit from having a comprehensive WSH system in place.

To start the bizSAFE journey, an enterprise's top management has to sign up for this bizSAFE Level 1.

OBJECTIVES
