Prof Arnoud De Meyer is a global academic leader with more than 35 years of experience in international academic institutions in Europe and Asia. Until December 2018, he served as President of Singapore Management University (SMU). Before joining SMU, Prof Arnoud De Meyer was from 2006 until 2010 Director (Dean) of the Judge Business School at the University of Cambridge (United Kingdom). From 1983 until 2006, he was a faculty member at INSEAD and assumed between 1990 and 2006 several management positions, among others as founding dean of INSEAD's Asia campus in Singapore.

Prof Arnoud De Meyer served as an independent director of several companies and non-profit organisations in Belgium, France, Singapore and Australia. He currently chairs the Temasek sponsored "Stewardship Asia Centre" (Singapore).

He is an internationally recognised researcher in the areas of R&D and Innovation Management, Manufacturing Strategy and International Management. He published more than 100 academic articles and 12 books, most recently "Ecosystem Edge: Sustaining Competitiveness in the Face of Disruption" and "Building Excellence in Higher Education: the Singapore's Experience".

Mr Kelvin Wong is the Chief Executive Officer of the Building and Construction Authority (BCA).

Prior to joining BCA, Kelvin was the Executive Vice President of the Singapore Economic Development Board (EDB). At the EDB, Kelvin oversaw the development of strategic growth engines in Hub Services and Supply Chain & Connectivity as well as the board's new businesses and policy and planning divisions. Kelvin started his career with EDB in 1996 and had helmed various key portfolios including logistics, professional services and urban solutions. Kelvin had served on the board of Singapore's Employment and Employability Institute (e2i) and is also the alternate board member of the Human Capital Leadership Institute (HCLI).

Kelvin is a Glaxo-EDB scholar who graduated from the Imperial College, University of London (Masters in Communications and Signal Processing and a First Class Honours in Electronics and Electrical Engineering) in 1996.

Mr Paul Chong is President and Group CEO of Certis Group. Headquartered in Singapore, Certis is an advanced integrated security services provider with revenues of more than S\$1 billion, and a global footprint across Australia, China, Hong Kong, Macau, Malaysia, Qatar and the UAE.

Paul joined Certis as the founding CEO of the current privatised entity in 2004, when Certis was a statutory board of Singapore's Ministry of Home Affairs. In under 15 years, he has grown the business more than five-fold, and has successfully diversified into new businesses to meet the changing nature of customers' needs while strengthening the group's core capabilities. From a single provider of auxiliary police services, Certis is now the leader in the field of advanced integrated security services. Certis has also recently become the third largest player in its industry in Australia.

Prior to joining the commercial world in 1995, Paul was the Head of Joint Communications & Electronics (HJCE) of the Singapore Armed Forces (SAF). As HJCE, Paul was the most senior SAF officer responsible for designing, building, operating and protecting the SAF's critical computers and communication systems against adversaries.

Paul joined SingTel in 1995 as Vice President for Consumer Sales. During his 5-year tenure at Singtel, he was credited for turning around the then loss-making Globe Telecom to become the leading mobile telecom operator in the Philippines. Paul was also integral to the rollout of the world's first nationwide broadband network in Singapore.

Paul left SingTel in 2000 to start his own broadband/multimedia company, before joining Commercial and Industrial Security Corporation (CISCO), the predecessor to Certis, in 2004. Paul attended Cambridge University (UK) in 1982 on a Singapore Armed Forces Overseas Scholarship, graduating with Honors in Economics and Operations Research. He is also a graduate of the US Army Command & Staff College.

Mr Allan Tan has worked in the construction field for 40 years on projects In Europe, Africa and Asia. Spending the last 20 over years in Singapore, he has attained an enormous insight into the Singapore built environment industry and engages with BCA, developers, and consultant leaders in spearheading construction innovation and technology.

In the last seven years, he has pioneered steel and concrete PPVC system and followed through by partnering with BCA and Consultants in pushing for continued PPVC adoption in projects nationwide. He has successfully implemented PPVC in residential, hotel and healthcare projects, including the then world's tallest PPVC project (40 storeys).

In 2018, Allan set up his own company, United Tec Construction. In the company's four years of operation, they have achieved an order book exceeding S\$1billion, and have been awarded six PPVC projects. The first project awarded was the Avenue South Residence, which at 56 storeys, will be the future world record holder of the tallest PPVC structure in 2022. Despite recent global challenges, the Avenue South Residence project is expected to be completed on schedule partly due to the use of PPVC. Allan is currently focused on growing his company, and also help the industry continue to adopt innovative methods to improve productivity.
