(PART II) COVID-Safe Training for Workers

<u>Important:</u> The course will be discontinued in June 2021. Application to attend the course must be submitted latest by 31 May 2021. Those who had already applied for the course but pending completion will be required to complete and pass the course by 10 June 2021. With effect from 1 June 2021, it will not be necessary for workers to attend and pass this course. Relevant Covid-safe training content and knowledge will be covered under the Apply Workplace Safety and Health (AWSH) in Construction Sites Course, previously known as the Construction Safety Orientation Course (CSOC), for new workers from 1 June 2021. (Updated on 12 May 2021)

A. <u>OVERVIEW</u>

Q1: As the COVID-Safe Training for Workers course will be discontinued in June 2021, when is the last day to register and complete the course?

The course will be discontinued in June 2021. Workers who are required to attend the course must complete their registration latest by 31 May 2021. All workers who had already registered for the course but pending completion must complete and pass the course by 10 June 2021.

Q2: How can my workers learn about Covid safety after the course is discontinued?

After the course is discontinued, the relevant Covid-safe training content and knowledge will be covered under the Apply Workplace Safety and Health (AWSH) in Construction Sites Course, previously known as the Construction Safety Orientation Course (CSOC), for new workers from 1 June 2021. Safe Management Officers (SMO)s Course for Construction (Virtual Classes)

[wef 1 July 2021 (new course code: 45032 – previously 45028)]

A. <u>OVERVIEW</u>

Q1: What is Safe Management Officers (SMO)s Course for Construction (Virtual Classes)? How different is this course from the previous SMO course that was launched in 2020?

The course is specially curated for the construction sector, to equip Safe Management Officers (SMO)s and Safe Distancing Officers (SDO)s with the knowledge and skills to implement and coordinate a system of Safe Management Measures (SMM)s suitable for the sector.

The content of the course is the same as the previous SMO course (previous course code: 45028). The key revision is in the delivery mode of the course. From 1 July 2021, the course (course code: 45032) will be revised to be conducted in asynchronous format where recorded video lectures, reference materials and short quizzes will be delivered to participants via the BCA Academy Learning Management System. Participants shall log in and learn the training content at their own time and pace, and to complete the course within 3 days. They will also need to complete end-of-course assessment online.

The course fee is \$40.00 (incl. 7% GST) per participant, and course fee subsidy is not available. To download brochure for more details, please visit <u>www.bcaa.edu.sg</u>

Q2: Why is the delivery mode of the course revised?

The course delivery is revised to provide participants with greater flexibility and direct access to the SMO training. In the virtual mode delivery, participants would be able to commence the course at their own time and pace from course start date and to complete it in 3 days. Within this 3-day timeframe, participants can also log in again to access the course materials to strengthen/revise learning accordingly.

Q3: Who should attend this course?

All SMOs and SDOs who are involved in Construction Projects and Supply Works are required to attend and pass the course, in order to meet the COVID-Safe Worksite criteria for resumption of works. Please refer to Table 1 for the training requirement for different work categories.

Q4: Does personnel involved in renovation projects need to attend the SMOs Course for Construction?

The SMOs Course for Construction does not apply to renovation companies. There is no need to attend the course.

Q5: What is the course fee? Is funding available?

The course fee for the virtual class (course code: 45032) is \$40.00 (incl. 7% GST) per participant. Course fee subsidy is not available.

If you are keen to utilise the course fee funding under <u>Enhanced Training</u> <u>Support for SMEs</u>, or <u>SkillsFuture - SkillsFuture Mid-Career Enhanced</u> <u>Subsidy</u>, or <u>Workfare Training Support Scheme - Individuals</u>, you may still apply for the previous course (course code: 45028). However, the course fee subsidy will expire on 30 June 2021. From 1 July 2021, the SMO course will only be conducted in the virtual format (course code: 45032).

Q6: Will there be any assessment at the end of the course? What is the format of the assessment?

Yes. At the end of the course, participants will be assessed via multiplechoice questions format in the BCA Academy Learning Management System. Upon successful completion and passing the course, participant should take a screenshot of the assessment result for reference. An e-Certificate of Successful Completion will be issued within a month upon completion of the course and full payment.

Q7: What is the format of the assessment?

The assessment will consist of scenario-based objective type questions. Participants will be allowed to attempt the assessment multiple times until they pass the course, without any additional fees.
