OVERVIEW

The Singapore Mediation Centre, as the Authorized Nominating Body under the Building and Construction Industry Security of Payment Act 2004 ("SOP Act") & the Building and Construction Authority are pleased to jointly organize the 4th National Conference on Construction Adjudication.

This Conference, fittingly held on the 20th Anniversary of the SOP Act coming into force on 1 April 2025, will traverse a broad canvas of diverse topics that is bound to be of interest to all stakeholders in the construction industry, such as developers, contractors, suppliers, consultants and construction lawyers.

The Conference begins with a retrospective on key milestones in statutory adjudication, reviewing landmark decisions that shaped the construction payment landscape. A comparative analysis follows, highlighting similarities and differences between the SOP Act and regional legislation. Stakeholders then share their experiences with adjudication, alongside legal experts discussing its practical implications. The event concludes with bold predictions on the future of adjudication and a lively debate on a (intentionally) provocative topic.

Developments in Security of Payment Adjudication in the Region



MODERATOR Chow Kok Fong, Director, Equitas Chambers Ltd

Chow Kok Fong, PBM is a Chartered Arbitrator. He was previously CEO of Changi Airports International and the Construction Industry Development Board (a government body) and has held appointments as Chairman and Managing Director with a number of major construction and real estate companies.

Mr Chow was founding President of the Society of Project Managers, former Chairman of the Society of Construction Law Singapore and was Chairman of the SMC Construction Adjudicators Committee from 2005 to 2025. He also chaired a Ministry of Law Working Group drafting the Singapore Infrastructure Dispute Protocol published in 2018 and has served as a member of the Singapore Government Ministry of Finance Development Projects Advisory Panel since 2012. He was referred to by the Singapore Chief Justice as "the doyen of Singapore construction law".

His 23 books on the subject have been widely cited by the Courts in Singapore, Malaysia as well as arbitrators, adjudicators and academic writers on construction law.

Judicial Commissioner Alex Wong Li Kok was appointed Judicial Commissioner of the Supreme Court on 1 August 2023.

He graduated from the University of London, Queen Mary and Westfield College with a Bachelor of Laws (2nd Class Upper) in 1996. He was called to the Singapore Bar in 1999 and admitted as a solicitor in England and Wales in 2007.

Judicial Commissioner Wong started his career as an associate with Colin Ng & Partners before joining Lee & Lee. He was a Partner in Lee & Lee from 2005 to 2007 before joining Hogan Lovells Lee & Lee where he specialised in energy, utilities and infrastructure projects. Mr Wong was made a Partner of the same firm in 2011 and, in 2020, he was appointed as the Office Managing Partner of Hogan Lovells Lee & Lee.

Lawyers should be Banned from Conducting **Adjudications**




