
Health Promotion Board (HPB) Swab Registration System 保健促进局拭子检测登记系统

Major COVID+ Outbreak at Project Glory COVID在Glory 项目的爆发

Worksites are potential "hubs" of virus transmission leading to multiple clusters 工地是导致多个集群的病毒传播的潜在"枢纽"




- Largest construction site cluster linked to 6 dormitories
- · Work at site was halted
- 链接到6个宿舍的最大建筑工地集群
- 工地被暂停

Key Lessons from Recent Outbreak 最近爆发的主要教训

COVID Outbreak COVID爆发

- 6 COVID+ cases were first confirmed among a 8-man team working in the Middle work zone
- Quarantine Orders (QO) issued to 356 close contacts in workplace, place of residence, and through social interaction
- 在中部工作区工作的8人团队中,首先确认了6例COVID +病例
- 通过工作场所,居住地以及通过社交互动向356位密切联系人发布了隔离令(QO)



Risk of spread from middle to East and West work zones 从中部蔓延到东部和西部工作区的风险

Causes原因

- Common lunch and rest areas workers from 3 work zones used shared facilities
- Company transportation workers across 3 work zones took the same transport to/from place of residence
- Common residence workers from different work zones shared the same residence and socially interacted with one another
- 公共午餐和休息区-3个工作区的工人共享设施
- 公司交通-3个工作区的工人以相同的方式往返于居住地
- 共同居所-来自不同工作区的工人共享同一居所并彼此进行社交互动

Key Lessons from Recent Outbreak 最近爆发的主要教训

Actions Taken 所采取的行动

- MOH served Stop Work Order, Site closure and Disinfection
- Locked down entire block of residence with 77 workers having to be conveyed to Government Quarantine Facilities (GQFs) and 144 workers quarantined in-situ
- 卫生部下达了停工令,工地被关闭和消毒
- 封锁了整个住宅区,将77名工人转移到政府隔离设施(GQF),将144名工人进行现场隔离

Key Lessons Learnt 吸取的主要经验教训

- Cohort workers according to work zones
- No mixing of different cohorts during transportation and in places of residence to prevent cross infection
- Segregate workers from different work zones and stagger the timing for use of common lunch and rest areas/disinfect
- 按工作区域划分的**同类工人群组**
- 在交通过程中以及在居住地不得混合不同群组的工人,以防止交叉感染
- 将来自不同工作区的工人隔离开来,并错开使用共同午餐和休息区/消毒的时间

Key Things to Look Out for 需要注意的关键事项



1) Safe Access 安全通行

- Entry control (approved workers only, roving sub-contractors and visitors do not mix with workers on site)
- 进入控制(仅允许经过批准的工人,巡回分包商和访客不得与现场工人混在一起)



2) Safe Distancing 安全距离

- Safe Management Officer/Safe Distancing Officer 安全管理人员/现场安全距离监督员
- Segregation of Teams & Work Zones (communal facilities are hot spots) 团队和工作区的分离(公共设施是热点)
- Pre-pack meals 预包装餐
- Turn on TT (Trace Together) app 开启TT (Trace Together) 应用程序



3) Containment 遏制

- COVID+ Response Plan (Cordon off affected zones, isolate worker, clean & disinfect, inform authorities)
- COVID+回应计划(封锁受影响区域,隔离工人,进行清洁和消毒, 并通知当局)





COVID+ Cases Related Response



COVID+ Worker

MOH:

- 1) Extract COVID+ worker
- Conduct contact tracing and issueQuarantine Orders

Worker's Residence

MOM:

- 1) Dispatch team to inspect the worker's residence
- 2) Ensure COVID+ worker is isolated and extracted to quarantine facility

Work Site

BCA:

- 1) Issue Safety Time-Out (STO) Notice for <u>all work</u> to stop (typically last 1 3 days)
- 2) Identify the work zones where COVID+ worker and close co-workers operate
- 3) Issue Stop Work Order (SWO) based on work zones (not affected zones may resume work)
- 4) Investigate breaches in SMM (enforcement action may be taken against non-compliances)

受感染员工

卫生部 (MOH):

- 1) 带离受感染员工
- 2) 进行接触者追踪, 发布隔离令

员工住处

人力部 (MOM):

- 1) 派遣团队到员工住处进行检查
- 2) 确保受感染员工在隔离中心接受隔离

工地

建设局 (BCA):

- 1) 对所在工地发出安全停工通知,工地停工 (一般1-3日)
- 2) 确认受感染员工与有过密切接触员工的工作 区域
- 3) 对受影响工作区域发出停工令(不受影响工作区可复工)
- 4) 调查安全管理措施方面的疏漏 (若发现违规行为可能有惩治)
