

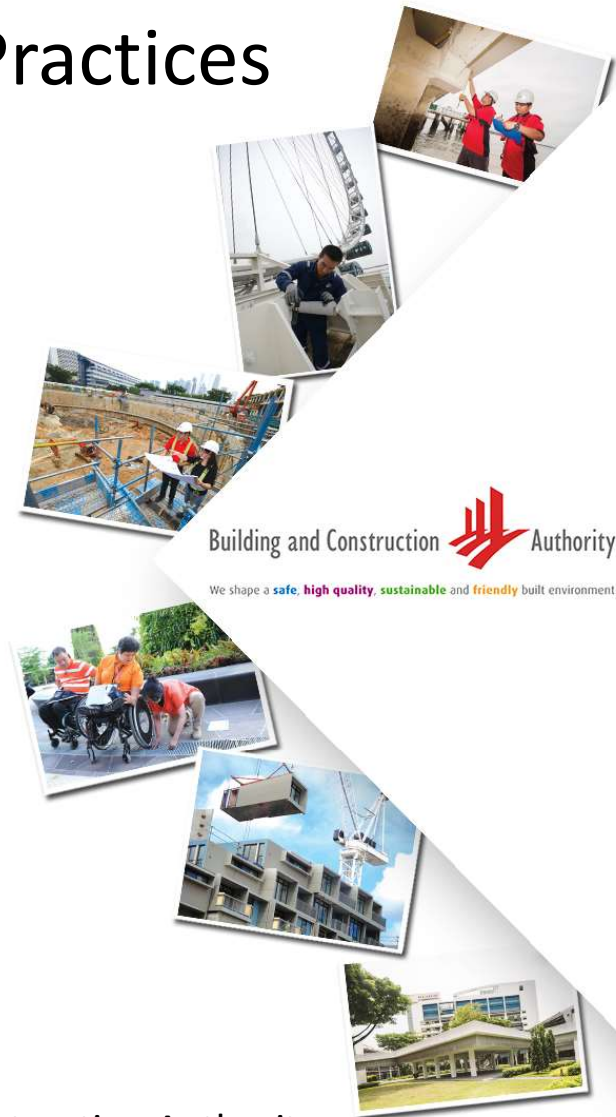

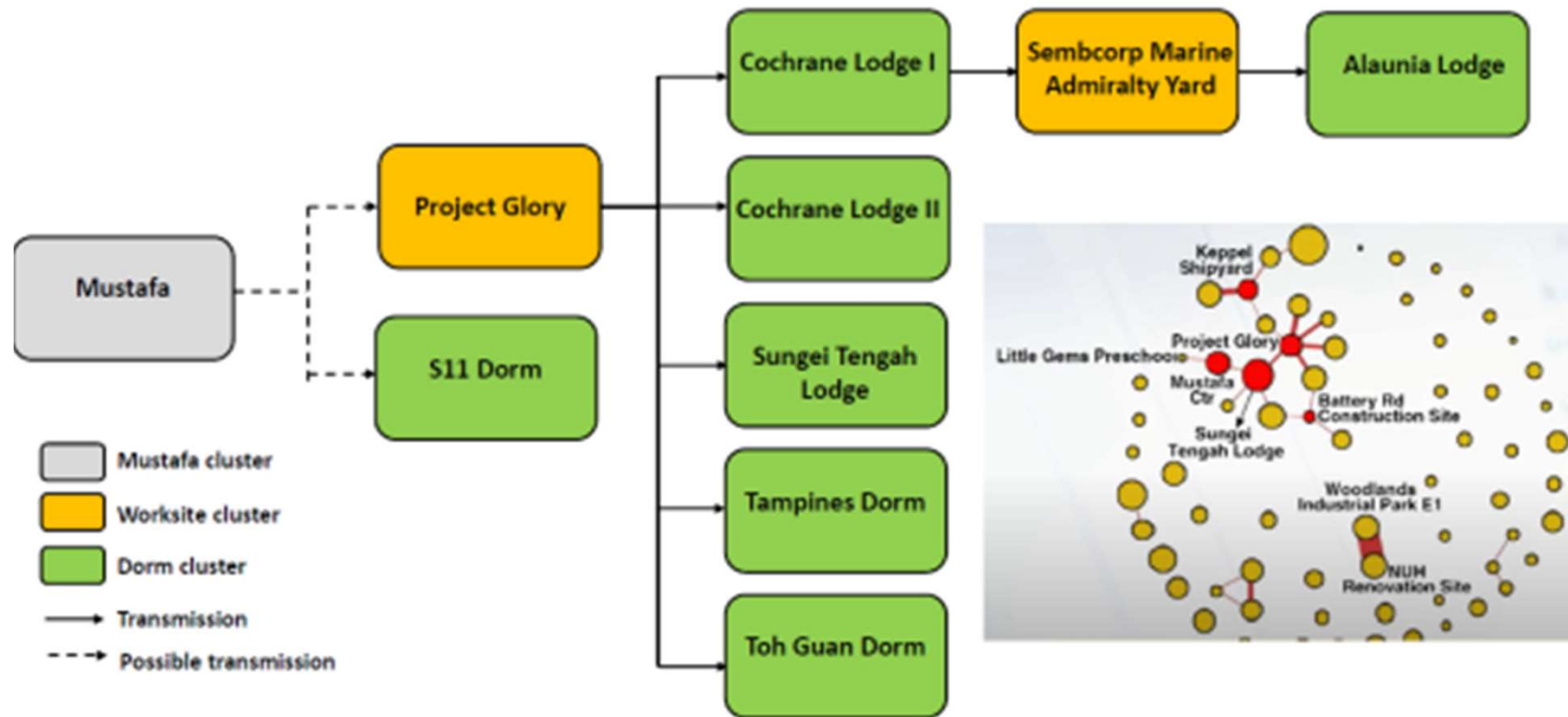
COVID-Safe Restart Criteria

To ensure a COVID safe Built Environment, all construction projects/supply work premises need to comply with the three COVID-safe Restart Criteria



Major COVID+ Outbreak at Project Glory

Worksites are potential “hubs” of virus transmission leading to multiple clusters



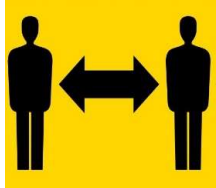
- Largest construction site cluster linked to 6 dormitories
- Work at site was halted

Preventing Major COVID+ Outbreak

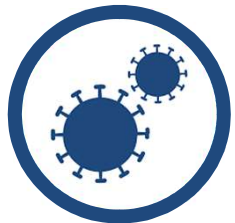
Key Objectives



1) Safe Access: Allow only healthy and approved workers to work at worksites



2) Safe Distancing: Enforce safe-distancing, segregation and cohorting measures at worksites



3) Containment: Ensure COVID+ and quarantined workers are isolated swiftly

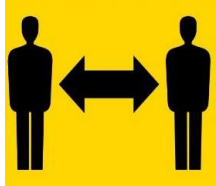
Preventing Major COVID+ Outbreak

Key Things to Look Out for



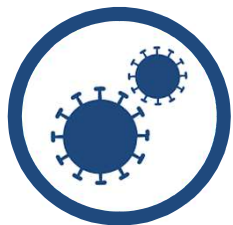
1) Safe Access

- **Entry control**
(Implement Safe Entry [NRIC], approved workers only, roving sub-contractors and visitors do not mix with workers on site)



2) Safe Distancing

- **Safe Management Officer/Safe Distancing Officer**
- **Segregation** of Teams & Work Zones (communal facilities are hot spots)
- **Pre-pack meals**
- Turn on **TT (Trace Together)**



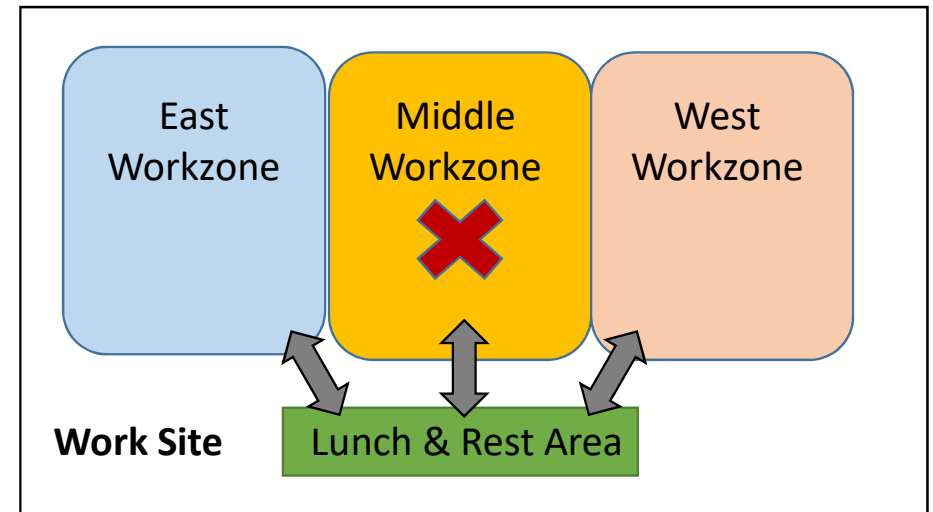
3) Containment

- **C+ Response Plan**
(Cordon off affected zones, isolate worker, clean & disinfect, inform authorities)

Key Lessons from Recent Outbreak

C+ Outbreak

- 6 COVID+ cases were first confirmed among a 8-man team working in the Middle work zone
- Quarantine Orders (QO) issued to 356 close contacts in workplace, place of residence, and through social interaction



Risk of spread from middle to East and West workzone

Causes

- **Common lunch and rest areas** - workers from 3 work zones use shared facilities
- **Company transportation** - workers across 3 work zones take same transport to place of residence
- **Common residence** - workers from different work zones share same residence and socially interacted with one another

Key Lessons from Recent Outbreak

Actions Taken

- MOH served Stop Work Order, Site closure and Disinfection
- Locked down entire block of residence with 77 workers conveyed to GQFs and 144 workers quarantined in-situ

Key Lessons Learnt

- **Cohort workers** according to work zones
- **No mixing of different cohorts** during transportation and in places of residence to prevent cross infection
- Segregate workers from different work zones and **stagger the use of common lunch and rest areas**

BCA's Audit Findings

A. Mismatch in entry records with approved workers list

Main reasons:

- SMO did not realise that workers were rejected
- Builder just submitted updated personnel list to BCA but hasn't been approved
- Builder added manpower to site to cope with worker shortfall but did not submit new list to BCA
- Builder submitted new manpower to BCA but did not include previous approved list of personnel
- SMO did not know that they/essential workers/SC/PRs/Sub-cons have to be included in the list

Builder/SMO must not deploy non-approved workers/personnel at site until they are approved by BCA to work at site

A. Mismatch in entry records with approved workers list – To update manpower list

BCA's Audit Findings

B. SafeEntry (NRIC Version) System not installed and used at site to manage entry/exit of all personnel entering the site

- Builder implemented a SafeEntry System (QR Code) instead
- To implement SafeEntry System (NRIC) as it is linked to MOM access code



SafeEntry

Use SafeEntry to check in and check out for contact tracing

Present barcode on photo ID for scanning

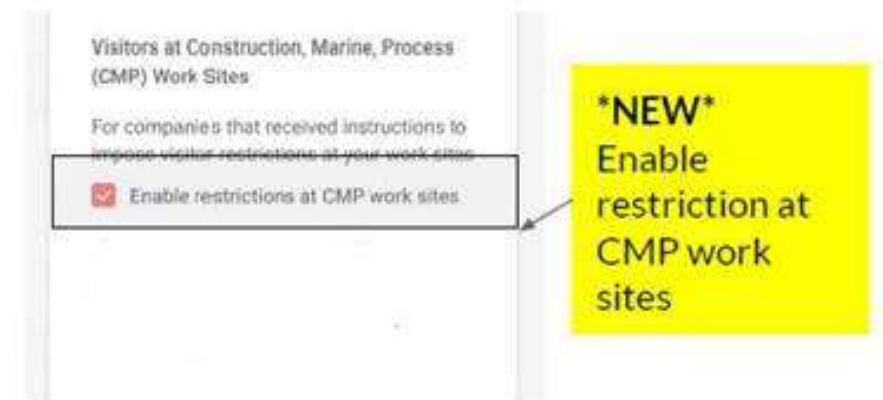

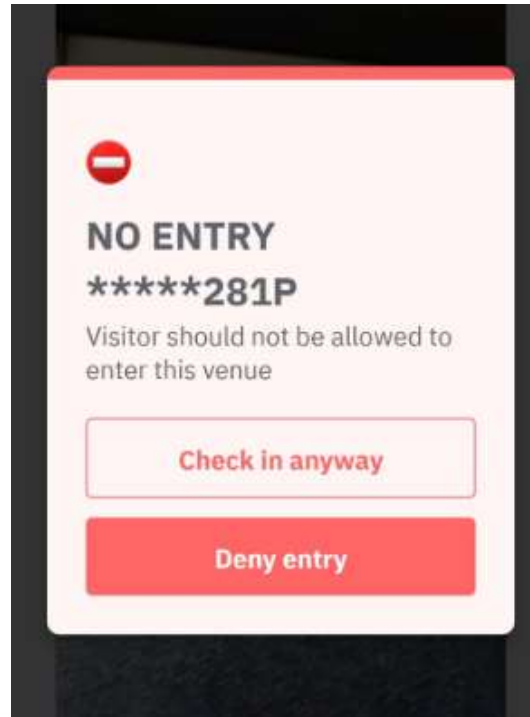

SafeEntry (NRIC) Version

- Builder must **enable restrictions for SafeEntry (NRIC) at worksite** to read the access code status of personnel entering the site to prevent unauthorised entry
 - SMOs can use SafeEntry (NRIC) scanner to check if restriction has been enabled. If scanner did not show access code colour, it means restriction is not enabled.
 - Refer to SafeEntry (NRIC) User Guide for Construction, Marine and Process (CMP) Work Sites



SafeEntry (NRIC) Version



NOTE

- **DO NOT ALLOW** any workers flagged as **RED** into site
- BCA will take actions against unauthorised entry

BCA's Audit Findings

C. Missing SMM monitoring plan on site to ensure compliance with Safe Management Measures

What to include in SMM Monitoring Plan:

- **Segregation plan** (different work zones for different team of workers) – *for large sites*
- **Cohorting plan for workers** (e.g. dedicated accommodation for workers from different teams to prevent mixing)
- **C+ and suspected cases control and management plan**
- **Site communication plan** to communicate SMM requirements to workers (e.g. briefing on SMM to site personnel/workers)
- **System to track non-compliance issues** to ensure that they are rectified without further delay
- **System to prevent SMM breaches** (e.g. not wearing mask, not practicing safe distancing, sharing of meals)

SMM Monitoring Plan

Evacuation Plan for Suspected case

SMM to put in place an evacuation plan for suspected cases, as well as for all other onsite personnel:

- a) Builder to provide adequate sick bays (in compliance with MOM's requirements) for timely segregation of suspected cases.
- b) Builder to convey worker to clinic as soon as possible.
- c) Any other employee who is feeling unwell or showing symptoms of illness to report to his employer, leave the workplace and consult a doctor immediately, even if symptoms may appear mild.
- d) Builder must track and record these cases as part of safe management measures.

SMM Monitoring Plan

Follow-up Plan for Confirmed Covid+ case

SMOs to put in place a follow-up plan in the event of a **confirmed case**:

- a) SMO to immediately vacate and cordon-off the immediate section of the workplace premises where the confirmed case worked.
- b) The team that the confirmed worker belongs to should be put into isolation.
- c) Builder to carry out a thorough cleaning and disinfect entire site, in accordance with NEA guidelines.
- d) Builder to inform BCA of any confirmed cases immediately

BCA's Audit Findings

D. Inadequate no. of Safety Management Officer (SMO)/Safe Distancing Officer (SDO)

- Total no. of workers ≤ 10 = 1 SMO;
- Total no. of workers > 10 but ≤ 50 = 1 SMO & 1 SDO
- Total no. of workers > 50 = at least 1 SMO & 1 SDO for every 50 workers)



SMO and SDO must be present on site at all times when works are being carried out. If the SMO/SDO cannot be on site (e.g. MC, on leave), there must be another SMO / SDO on-site to cover him/her.

BCA's Audit Findings

E. Meals not individually packed – cooking at site



- Builder to provide individually packed meals, and to remind workers not to share tableware and cutlery
- No cooking allowed on site

BCA's Audit Findings

F. No proper sick bay / No isolated sick bay at site



Sick bay within the office



Sick bay not fully enclosed

To provide a separate area within the work site as a sick bay that is fully enclosed for the isolation of suspected C+ personnel





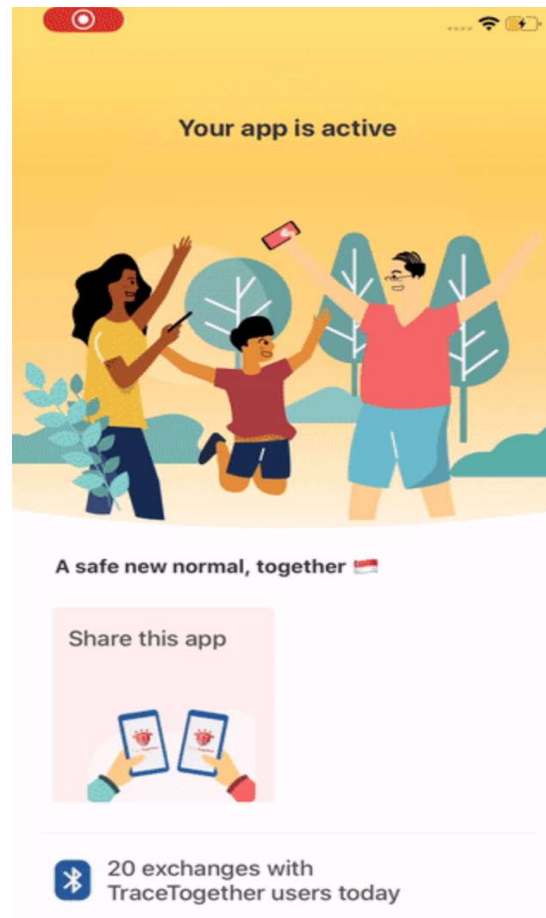

- Ensure workers **activates** the TT app at all times

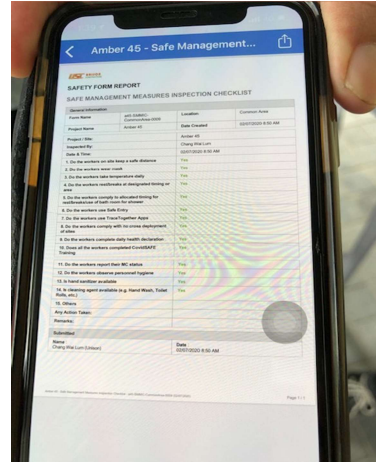

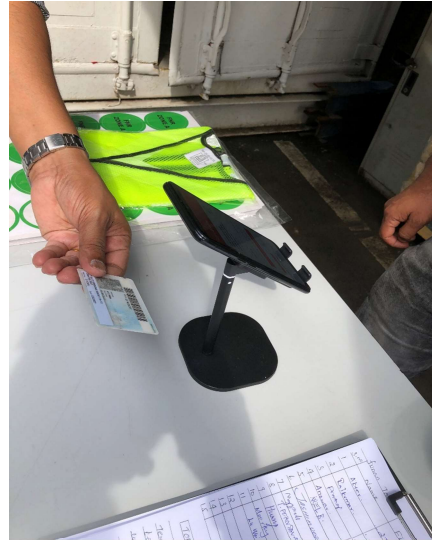

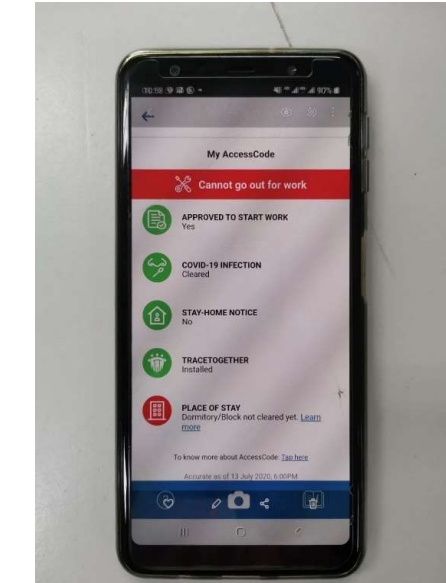

- Prosecution, Composition Fines, Stern Warning
