# COVID-Safe Workforce

**During 1<sup>st</sup> day of restart work, a COVID-Safe briefing shall be conducted by our COVID-Safe Management Officer :**

- Workers to download contact-tracing app TraceTogether
- SGworkpass App to track the Accesscode status of workers
- Regular COVID-19 testing for the workforce
- Workers to minimize their social interactions

# COVID-Safe Worker Accommodation & Transportation

Mitigate risk of potential infection in the community by ensuring dedicated **transport** between worksite and places of **accommodation**.

- Respective dormitory management to Implement strict safe management measures to prevent outbreaks at places of accommodation.
- Respective contractor to arrange dedicated transportation for each construction site.

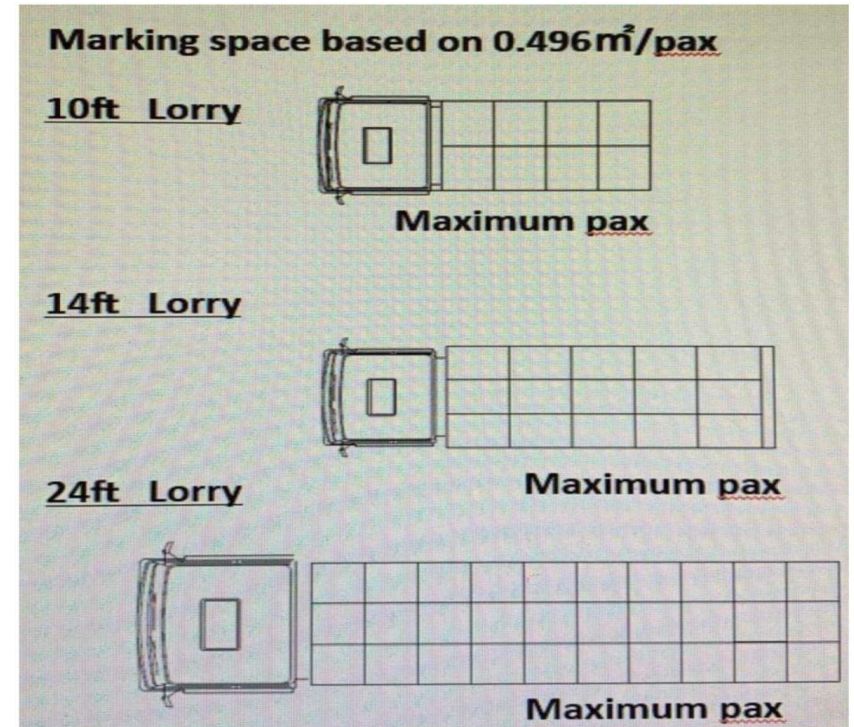
# COVID-Safe Worker Accommodation & Transportation

- Ensure safe distancing in workers' accommodation and transportation



# COVID-Safe Worker Accommodation & Transportation

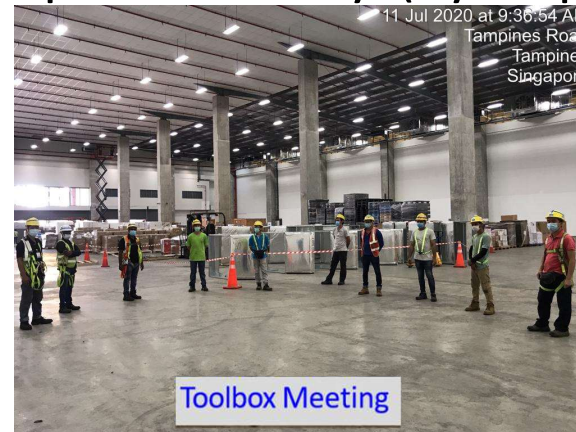
- Workers to be seated at safe distance apart while wearing masks
- Disinfecting of vehicles after transporting each team.



# COVID-Safe Worksite

## 1) Implement a System of Safe Management Measures at Worksites

- Appointment of SMO & SDO.
- Each team's supervisor shall be acted as COVID-safe team leader, responsible to ensure the COVID-safe compliance of his team workers.
- Safe Distancing induction during tool box meeting in every morning (by respective supervisor and recorded in TBM form).
- Posters and infographics in native languages to remind and keep workers updated on measures and importance of personal hygiene.
- Pre-screening of health status of workers prior to entry. (by respective supervisor and to record in Health recording form)

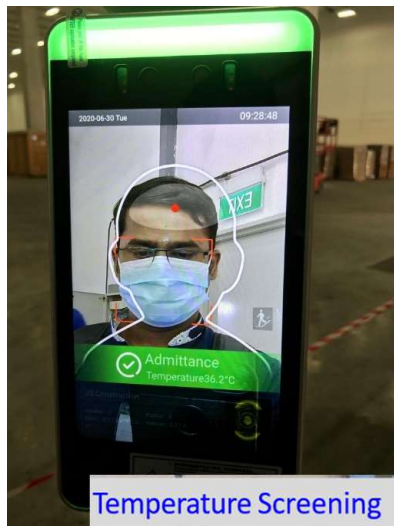




# COVID-Safe Worksite

## 1) Implement a System of Safe Management Measures at Worksites (cont'd)

- Monitor temperature of workers twice daily (by respective supervisor and recorded in Health recording form – can be computerized or manual)
- Safe distancing during Toolbox Meeting (by respective supervisor and recorded in Health recording form)



# COVID-Safe Worksite

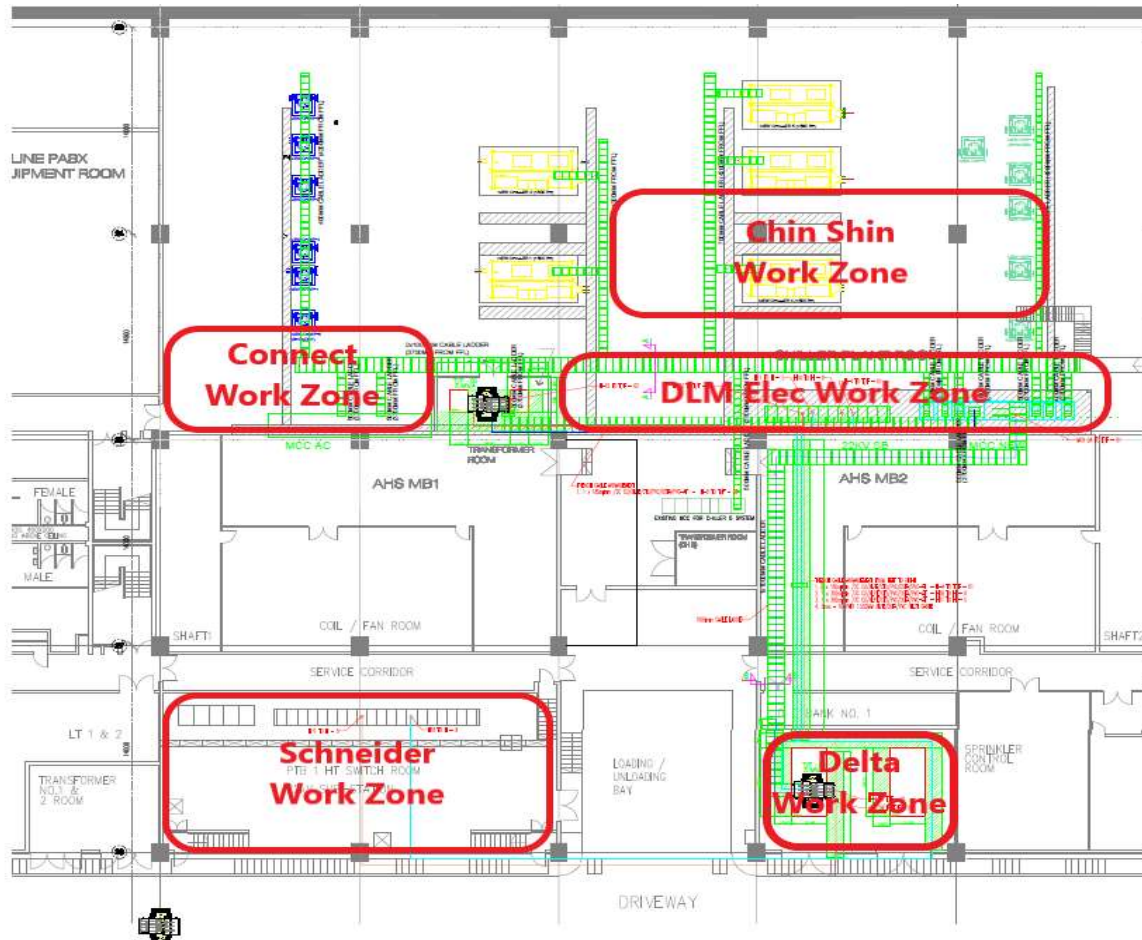
## 2) Reduce physical interaction & ensure safe distancing at worksites

- Workforce shall have staggered hours for breaks. (SMO, SDO to assign and monitor)
- Segregate workers undertaking the same activity into teams, with each team restricted to working within a single zone. (SMO, SDO monitor)
- Each team of workers works within their designated zones and away from workers of other teams. (SMO, SDO monitor)
- Each team shall be given different color tape on helmet to ease monitoring. (SMO, SDO monitor)
- SMO & SDO to carry out inspection to ensure the compliance and documents any findings and corrective actions. (every Tuesday & Friday)

## 2) Reduce physical interaction & ensure safe distancing at worksites



# COVID-Safe Worksite

- 2) Reduce physical interaction & ensure safe distancing at worksites (cont'd)
- Avoid physical meeting if possible (SMO to manage)
  - Safe distancing at site office and meeting room (SMO & SDO to observe)



# COVID-Safe Worksite

## 3) Ensure Cleanliness of Worksite Premises

- Disposal of waste on site at the end of everyday (SDO to monitor)
- Workers rest at well ventilated loading/ unloading bay with safe distancing (SDO to monitor)
- Hand sanitizer is provided at the site entrance. (SDO to monitor and refill where necessary)
- To wipe tool's handles with disinfectant before use. (SDO & respective supervisor to monitor)

## 4) Delivery/Logistics personnel

- Materials delivery personnel must wear mask and keep a minimum distance of 1m away from workers. (SDO & respective supervisor to monitor)

# COVID-Safe Worksite

## Role and Responsibility of Safe Management Officers

- SMOs to coordinate the implementation of Safe Management Measures, which include identifying relevant risks, recommending and assisting in implementing measures to mitigate the risks, and communicating the measures to Safe Distancing Officers (SDO) and all workers in the construction site.
- SMOs to brief SDO team on corrective actions to be carried out if non-compliance is detected.
- SMOs to conduct regular inspections and checks to ensure compliance, and to report to main con and document any non-compliance found during the inspections.
- SMOs to take immediate action to remedy any non-compliance found during the inspections and checks.
- SMOs to keep records of inspections and checks conducted and corrective actions taken.
- SMOs to review SMMs if constant non-compliance is detected.

# COVID-Safe **Worksite**

## **Role and Responsibility of Safe Distancing Officers**

- To ensure that workers within their assigned teams will adhere to the safe distancing measures and the instructions given by Safe Management Officers (SMO).
- SDOs to assist the SMOs to conduct regular inspections and checks to ensure compliance, and to report to the SMOs and document any non-compliance found during the inspections.
- SDOs to notify project SMOs if non-compliance is detected and carry out possible corrective actions as discussed with SMOs.
